## Subject: AmeriHealth Caritas Louisiana to Convert to Diagnosis Related Group System (DRG)

**Summary:** In conjunction with the Louisiana Department of Health, AmeriHealth Caritas Louisiana will transition to a Diagnosis Related Group System (DRG) **effective January 1, 2019.** 

#### What is DRG?

DRG payment is a method used to classify an inpatient stay. DRGs are used to gather insight, risk adjustment and then determine a price based on the classification of the hospital stay and the specific hospital where the services were performed.

Classification of the hospital stay is based on the following:

- Reason for admission.
- Severity of illness.
- Diagnosis describing the patient's condition.
- Surgical procedures performed (if any)
- Patient age
- Patient gender
- Discharge status

The classifications are labeled using codes referred to as DRG codes; each DRG code is weighted, which is intended to indicate the average relative amount of hospital resources required (minor, moderate, major and extreme) to treat patients within that DRG category.

#### Who will be impacted?

All hospitals that provide acute care, mental health/substance abuse services, physical rehabilitation and transplant services.

#### What does this mean for you?

In the coming months, AmeriHealth Caritas Louisiana will offer trainings to prepare providers for the upcoming changes **effective January 1, 2019.**
