## By **July 1, 2019**:

- Write a new prescription for the PDL alternative product, if clinically appropriate, for your AmeriHealth Caritas Louisiana patients currently receiving the medication listed above under "PDL Removal".
- If it is not clinically-appropriate to switch an AmeriHealth Caritas Louisiana patient to the PDL alternative, you will need to request prior authorization for the patient to continue to receive coverage for the non-PDL medication.
