Overview:

The <u>Center for Evidence to Practice</u> (Center for E2P) has released a Request for Application (RFA) in order to identify behavioral health practitioners in Louisiana who are equipped to successfully participate in Child-Parent Psychotherapy training and implementation.

Through the Request for Applications (RFA), the Center for E2P and Drs. Amy Dickson, Julie Larrieu, and Devi Murphy, look forward to identifying a strong cohort to participate in this training and learning collaborative opportunity.

The Child-Patient Psychotherapy training is scheduled to begin in **August 2023** and continue for 18 months.
