Subject: NaviNet Enhancement - Behavioral Health Admission and Discharge Alerts

Summary: AmeriHealth Caritas Louisiana is pleased to announce an exciting new feature on NaviNet. Effective August 22, 2022, near real time member admission, discharge, and transfer (ADT) alerts are available in the provider portal for behavioral health providers.

AmeriHealth Caritas Louisiana has launched behavioral health ADT alerts as an additional resource for behavioral health providers. The ADT alerts notify attributed behavioral health providers when our members have been either admitted to or discharged from the hospital or treated in an emergency room within the last 7 days for a behavioral health condition.

This critical information is available via our secure provider portal, NaviNet, within 24 hours of the event, allowing behavioral health providers to identify members needing post-discharge follow-up visits.

Admissions and discharges are displayed as either Emergency Room Alerts or Inpatient Alerts.

Behavioral health providers are identified by their specialties. The member attribution logic for behavioral health providers is updated monthly. Members are assigned to the behavioral health providers who submit the greatest number of claims for members, indicating the members' care is primarily provided by those practitioners.

The following information is displayed for each alert:

The admission and discharge alerts can be accessed through the following steps in NaviNet:

- 3. Workflows Patient Clinical Documents AmeriHealth Caritas Louisiana,

4. Document Tags – enter "ADT"

To begin receiving ADT alerts in NaviNet, click the Activity Bell in the upper-right corner, then click the Settings tab. Check the box next to Incoming Documents.
