The ASAM Treatment of Opioid Use Disorder Course is designed for:

Physicians, Nurse Practitioners, Physician Assistants, Certified Nurse Midwives, Certified Registered Nurse Anesthetists, and Clinical Nurse Specialists who wish to obtain a waiver to prescribe buprenorphine in an office-based setting for opioid use disorder.

Course Format: Blended – Four hours live (in person or webinar), followed by four hours online

### FOLLOWED BY

This combined training of four hours live/four hours online satisfies the eight hours of education requirements for physicians to qualify for a DEA DATA2000 waiver. Upon completion of the course (4 hours live, 4 hours online), physicians qualify for the waiver to prescribe buprenorphine in an office-based setting. NPs and PAs can qualify after completing an additional 16 hours provided by ASAM, the American Association of Nurse Practitioners, and the American Academy of PAs.
