<u>Billing and Ordering Guidance for Long Acting Reversible Contraceptives (LARCs):</u> Intrauterine Devices (IUD) and Implants

Purpose:

This bulletin provides billing and ordering information for IUDs and Implants and includes information for each of the five Health Plans in an effort to have a 1-page document in order to simplify the various billing and ordering processes for providers. The ultimate goal is to remove barriers for women to access the most effective reversible contraceptives: intrauterine devices and implants (Centers for Disease Control).

Background:

<u>Inpatient Postpartum LARC Insertion</u>: Effective June 20, 2014, Louisiana Medicaid added coverage of intrauterine devices and implants, in addition to a hospital's per diem payment for women newly postpartum, prior to discharge. The payment for LARC is equal to the fee on the Durable Medical Equipment fee schedule.

<u>LARCs Reimbursement Rate</u>: Effective Fall 2014 reimbursement rates for intrauterine devices and implants were increased to the current wholesale acquisition cost and the rate is adjusted each Jan. 1 to the current wholesale acquisition cost.
