- Actionable care gaps are available to providers based on time of year and measure specifications. For example, some measures may not be available from Dec - Jan due to the high volume of non-compliance and the expectation of natural gap closure.
- To mitigate this, the schedule for January and December below focuses on select measures where the capability exists to proactively identify care gaps for member who may require service the following year.

Current Pharmacy Measures:

Service	Rule Of Frequency
Hydroxyurea Therapy	At Risk indicates Sickle Cell Disease that may benefit from Hydroxyurea therapy
Penicillin Prophylaxis	At Risk indicates Sickle Cell Disease that may benefit from Penicillin Prophylaxis
Past-due Refill: Hydroxyurea	At risk indicates non-adherence to Hydroxyurea
Controller: Controller and Rescue Ratio	At risk indicates under utilization/absence of controller medication
Blood Glucose Monitoring	At Risk indicates underutilization/ absence of blood glucose testing supplies
Past-due Refill: Statin	At risk indicates non-adherence to Statin
Past-due Refill: Renin Inhibitor	At risk indicates non-adherence to Renin Inhibitor
Past-due Refill: Inhaled Corticosteroid	At risk indicates non-adherence to Inhaled Corticosteroid
Past-due Refill: Oral Antidiabetic - DPP-4 Inhibitor	At risk indicates non-adherence to Oral Antidiabetic - DPP-4 Inhibitor
Past-due Refill: Oral Antidiabetic - DPP-4 Inhibitor & Biguanide	At risk indicates non-adherence to Oral Antidiabetic - DPP-4 Inhibitor & Biguanide
Past-due Refill: Oral Antidiabetic - Sulfonylurea	At risk indicates non-adherence to Oral Antidiabetic - Sulfonylurea
Past-due Refill: Oral Antidiabetic - Biguanide	At risk indicates non-adherence to Oral Antidiabetic - Biguanide
Past-due Refill: Oral Antidiabetic - Alpha-glucosidase Inhibitor	At risk indicates non-adherence to Oral Antidiabetic - Alpha-glucosidase Inhibitor
Past-due Refill: Oral Antidiabetic - Thiazolidinedione	At risk indicates non-adherence to Oral Antidiabetic - Thiazolidinedione
Past-due Refill: Oral Antidiabetic - Sulfonylurea/Biguanide	At risk indicates non-adherence to Oral Antidiabetic - Sulfonylurea/Biguanide

Service	Rule Of Frequency
Past-due Refill: Oral Antidiabetic - Thiazolidinedione/Biguanide	At risk indicates non-adherence to Oral Antidiabetic - Thiazolidinedione/Biguanide
HRM – High Risk Medications	At risk indicates a member age 65 or older who received one or more prescription for a high risk medication
Immunization: Flu	At risk indicates no claims for flu shot for the current season and age 65 or older
Past-due Refill: Oral Antidiabetic - Meglitinide	At risk indicates non-adherence to Oral Antidiabetic - Meglitinide
Past-due Refill: Antidiabetic - Incretin Mimetic	At risk indicates non-adherence to Antidiabetic - Incretin Mimetic
Past-due Refill: Harvoni	At risk indicates non-adherence to NS5B Polymerase/NS5A Inhib. Combo
Past Due Refill: COPD	At risk indicates non-adherence to COPD agents
OMW - Osteoporosis Management in Women	At risk indicates a female member age 67-85 who suffered a fracture and have no prescription for a drug to treat osteoporosis within 6 months of the fracture
ART - Rheumatoid Arthritis Management	At risk indicates a member diagnosed with rheumatoid arthritis in the measurement year and has no prescription for a DMARD
SUPD – Statin Use in Persons with Diabetes	At risk indicates Diabetes that may benefit from statin therapy
